3. The price of articles should be quoted inclusive of all taxes & transporting charges for delivery in the I.C.D.S Project.
4. The materials are to be delivered within 7 days from the date of supply order.
5. Sealed quotations will be received in the office of the I.C.D.S, Project Satyabadi during office hours on working days only.
6. The last date for submission of quotation is 26.02.2020 by 05.00 P.M. and the quotations will be opened on date 27.02.2020 at 11.00 A.M. in the office of the Sub-Collector, Puri in presence of the committee members & quotationer / their authorized agents.
7. The quotationer will submit samples of the quoted items before the members of purchase committee at the time of opening of quotations.
8. The purchase committee reserves the right to accept, reject any or all quotations without assigning any reason thereof.
9. The quotationer has to deposit **Rs.10,000/-** (Rupees Ten Thousand) only as security money in shape of **Cash/ Bank Draft** in the office of the C.D.P.O, Satyabadi and obtain **Money Receipt** for that. The Bank Draft will be prepared in favour of "C.D.P.O, Satyabadi".
10. The quotationer shall attach the Xerox copy of money receipt with the quotation as proof towards security deposit.
11. The security deposit amount of un-successful quotationers will be refunded on or after 28.02.2020 but the security deposit amount of the successful quotationer will be locked till supply of entire indented materials subject to forfeiture in case of non-supply of materials within the stipulated time limit.
