8. The quotationer will supply sample of the quoted item before the members of purchase committee at the time of opening of quotations.
- 9.The quotationer has to deposit Rs 10,000-00 (Ten thousand) only as security money in shape of cash/Bank Draft in favour of CDPO,Nimapada In the office of the CDPO,Nimapada and to obtain receipt thereof.
- 10.The Bank draft will be prepared in favour of CDPO,Nimapada in any Nationalized Bank payable at Nimapada.
- 11.The quotation should submit the quotation along with the Xerox copy of the money receipt in prove of deposit of security money.
