TERM AND CONDITIONS

- (a) The terms of engagement on honorarium (daily wage +COVID-19 incentive) basis is purely temporary.
- (b) The honorarium (daily wage +COVID-19 incentive) engagement can be terminated at any time without assigning any reason thereof.
- (c) The Remuneration shall be given as per Labour & ESI Department Notification No.11688/LC dt.07.11.2019 with special incentive for COVID-19
- (d) The honorarium (daily wage +COVID-19 incentive) personnel will give an undertaking at the time of joining to the effect that, he/she shall not claim for regular employment in state Government on account of such contractual engagement.
- (e) He/ She shall be responsible for safety and maintenance of all Government articles/ materials/records/ documents entrusted to him / her.
- (f) If the documents found false on subsequent enquiry, the contractual (Daily wage) service will be terminated and legal actions as deem fit will be initiated.
- (g) The period of honorarium (daily wage +COVID-19 incentive) basis engagement will be continued till 30th June 2020.The duration may be extended, if further required.
- (h) Unauthorized absence from duty, the honorarium (daily wage +COVID-19 incentive) engagement shall be automatically terminated.
- i) Further he/she must report before the concerned authority within five days on receipt of this order failing which the engagement order will be cancelled automatically.
- j. The engagement order will be cancelled for non production of document which is mentioned in (I)
