- (d) The contractual(Daily wage) employee will give an undertaking at the time of joining to the effect that, he shall not claim for regular employment in state Government on account of such contractual engagement.
- (e) He shall be responsible for safety and maintenance of all Government articles/ materials/records/ documents entrusted to him.
- (f) If the documents found false on subsequent enquiry, the honorarium (daily wage +COVID-19 incentive) service will be terminated and legal actions as deem fit will be initiated.
- (g) The period of honorarium (daily wage +COVID-19 incentive) basis engagement will be continued till 30<sup>th</sup> June 2020.The duration may be extended, further if required .
