
QUOTATION CALL NOTICE

Puri Municipality authority will not be responsible for delay in reaching the quotations in any manners.

TERMS AND CONDITIONS


1. The successful bidder after payment of the bid amount shall execute and agreement for the purpose.
2. The EMD of the un successful bidder shall be refunded after execution of the agreement with the successful bidder.
3. Any violation of the terms and condition in the agreement shall result in forfeiture of the SD and termination of agreement.
4. Quotations received beyond the scheduled time will not be accepted.
5. In case of any arrear dues of Municipality stands against the auction holder, the auction will be rejected and the EMD will be forfeited.
6. Highest quotationer has to deposit the bid amount within three days in full and in case of failure the auction will be rejected with forfeiture of EMD.
7. The quotationer should submit Elector's photo Identity Card, other documents in support of his identification.
8. In no case the request for concession in auction amount will be accepted/ considered.
9. The quotationers shall have to pay GST tax of 18% and income tax of 1% on the bid amount.

10. The quotationer must super scribe the name of Hoarding /Parking Place /Fish Market/ Slaughter House quotation notice No. with date on the sealed quotation cover, failing which the quotation will not be opened and will be rejected.
11. The quotation must be accompanied with a Bank Draft from any Nationalized Bank in favour of the Executive Officer, Puri Municipality, Puri towards cost of auction paper and earnest money deposit (EMD).
