

The authority reserves the right to modify/ reject any or all the quotation without assigning any reason thereof.





GENERAL TERMS & CONDDITION

1. The quotation must be accompanied by EMD of Rs.10000/- (Rupees Ten Thousand) only in shape of Demand draft of any Nationalized Bank in favour of the Executive Officer, Puri Municipality, Puri payable at Puri.
2. The cost of nonrefundable quotation paper amount of Rs.2000/- (Rupees Two Thousand) only, in shape of Demand draft of any Nationalized Bank in favour of the Executive Officer, Puri Municipality, Puri payable at Puri.
3. The Comprehensive Annual Maintenance contract will be for a period of one year starting from execution of agreement.
4. The Comprehensive AMC shall include maintenance of all the Air Conditioners including two servicing, Gas filling whenever required, replacement of compressor, if needed, cleaning of drainage and any other problem related to the ACs.
5. The interested firm shall be with experience of minimum 03 years in the similar field having 02-03 AMC in Government /Semi Government offices especially in & around Puri, Khurdha & Cuttack District.
6. The Firm shall have its own qualified A.C. Mechanics & the work should not be given to any other sub-contractor in any case.
7. Copies of agreement in support of having rendered the services of similar nature with other Government Organization/PSU should be enclosed with quotation.
8. Any break down call reported by this office should be attended within 24 hours. If any repairing of such break down cannot be completed within 24 hours in that case a stand by AC should be provided by the firm.
9. Payments for the annual maintenance will be made on equal installments after each quarter.
10. In case the service provider defaults in rendering the service beyond 24 hours in that case a penalty of Rs.100/- per day will be imposed for the delayed period. In that case the decision of the Competent Authority will be final & binding.
11. The selected firm has to sign a separate AMC agreement with this office & shall be binding upon the every clause of agreement.
12. The selected firm shall submit Rs.10000/- (Rupees Ten Thousand) as performance security in shape of Bank Draft drawn in any Nationalized Bank in favour of Executive Officer, Puri Municipality, Puri.
13. The envelope containing the bids should be super scribed "Quotation for AMC of Split ACs".
14. The period of validity of the quotation can also be extended if agreed to by the Quotationer & Executive Officer, Puri Municipality.
15. Bidders must indicate if their rate is inclusive of all applicable Taxes.
