Sealed auction is invited from the interested bidders for auction of non standard foundation paddy seeds of variety Mrunalini- 185.00 Quintals and Kalachampa- 255.80 Quintals of Kharif-2019 produce lying in Govt. Agril. Farm, Olan, Nimapada, Puri. The interested bidders should submit their auction paper in a sealed cover addressed to the Chief District Agriculture Officer, Puri on or before 17.11.2020 by 2.00 PM. The auction papers will be opened on the same date i.e. 17.11.2020 at 4.30 PM by the auction committee constituted for the purpose in the office chamber of Chief District Agriculture Officer, Puri in presence of the bidders or their authorized representatives. The interested bidders are to submit their auction papers along with the EMD of Rs.10, 000/- through Bank Draft in favour of "Chief District Agriculture Officer,Puri" payable at Puri & supporting document in favour of valid GST registration number. The earnest money will be refunded to the bidders after finalization of auction. The offset price per Quintal of non standard Paddy seeds is Rs. 1878/-, which is inclusive of cost of HDPE bags(MSP of Paddy Rs.1868/- + Rs.10/- for 5 HDPE bags @ Rs. 2/- each). The successful bidder has to deposit the total value of the 440.80 qtls. i.e auction price per qtl x 440.80 within 3 days in the office of the Chief District Agriculture Officer, Puri, failing which the earnest money deposited by the bidder will be forfeited. The successful bidder has to lift the entire stock of 440.80 qtls.of paddy within a week from the date of deposit of the total value at his own cost failing which the earnest money deposited by the bidder will be forfeited. The interested bidders can inspect the stock during office hours at Govt. Agriculture Farm, Olans,Nimapada,Puri. The committee reserves the every right to cancel the auction without assigning any reason or shift the time or date of the auction in case of non participation of sufficient bidders.




