Terms and Conditions:

- **Cost of Tender Paper:** The Tender specification can be obtained from the office of the Block Development Officer, Nimapara on payment towards the cost of Tender papers as mentioned above (Non-Refundable) in shape of Bank Draft or Demand only (No other modes will be entertained) drawn in favour of Block Development Officer, Nimapara in any Nationalized Bank having its branch at Puri on any working day from 03.02.2021 onwards for the above work.
- **Sale of Tender Papers:** the Tender documents will be sold from 03.02.2021 at Block office, Nimapara between 10.00 A.M to 5.00 P.M on working days only.
- **Date of receipt and mode of submission of Tender Papers:** The Tenderers have to submit the sealed tender papers in complete shape in the DROP BOX at the office of Panchayat Samiti, Nimapara. They can also send through Registered /speed Post directly to the official address of BDO, Nimapara. The last date of receipt of tender papers is 12.02.2021 up to 5.00 P.M. The undersigned will not be responsible for any postal delay if any or non receipt of the papers in time. The tenderers must superscribe the name of the work/project on the sealed envelope.
- **Date of Opening of Tender Paper.** The tender shall be opened on 15.02.2021 at 11.00 A.M. in the presence of the tenderers or their authorized representatives having written authorization for the purpose and the Block Tender Committee.
- **Earnest Money Deposit:** 1% (one percent) of the bid value in shape of post office Term Deposit/Short Deposit/N.S.C/K.V.P/Deposit Receipt of any nationalized bank duly pledged in favour of Block Development Officer, Nimapara shall be deposited. The Tender papers without required amount of E.M.D will not be considered and transfer or adjustment of E.M.D is also inadmissible.
- **Documents to be attached:** The following documents should be furnished with the tender papers failing which the tender will be liable for rejection.
 - E.M.D in prescribed mode duly pledged in favour of the Block Development Officer, Nimapara.
 - Attested copy of contractor Registration Certificate.(license)
 - GST registration certificate of the Bidder along with GST clearance certificate
 - PAN card issued by the Income Tax Authority.
 - Original money receipt granted by B.D.O, Nimapara towards cost of tender paper.
 - Attested copy of caste certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
 - The bidders have to produce an original affidavit in support of the authenticity of credentials attached with the tender papers.

- Attested copy of caste certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
- The bidders have to produce an original affidavit in support of the authenticity of credentials attached with the tender papers.
- The Engineering contractor desirous of availing exemption of EMD should submit an affidavit to the effect that he has not availed exemption of EMD facility more than three times in the current financial year.
- Joint venture consortium agreements are not allowed to participate in tender.
- Shortfall of any required documents and EMD, Tender paper is liable for rejection.
- Additional Performance Security Deposit : The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract.(Vide Works Department Letter No-13286 Date-07/09/2017, Govt. of Odisha, Work Department.)
- Forfeiture: The EMD amount will be forfeited, if the tender backs out from the offer acceptance of tender by the competed authority.
- The tenderer has to show all the required original documents at the time of opening of the tender for verification.
- If the less rate quoted by the tenderer is more than 10% an 15% the additional performance security is to be deposited in shape of NSC/KVP/BANK TRD/BANK DRAFT/BANKER PAPER which will be duly pledged in favour of BDO, Nimapara at the time of dropping of tender paper
- Submission of more than one tender paper by a bidder for a single work will be liable for rejection.
- The contractor must have executed similar nature of work and financial turn over in the last three years. The above information should be certified by the concerned authority not below the rank of BDO/Executive Engineer.
- If the rate quoted by the tenderers is found to be same, tender committee will decide the tender.
- An affidavit in support of the authenticity of documents including no relation to block staff certificate should be submitted.

- The Block Development Officer, Nimapara reserves the right to reject any or all the tenders without assigning any Reasons thereof. Other details can be seen in the bidding document.


