



The sealed tender in plain paper for each vehicle will be received by the concerned C.D.M & P.H.O, Puri in charge of the vehicle has above up to 5:00 PM dated 17.02.2021 and will be opened 4 PM dated 18.02.2021 by the C.D.M & P.H.O. in presence of the tender of their authorized representative. If this day is declared as Govt. Holidays, the, the, the tender will be opened in the next working day as per scheduled time. Sealed tender send by registered post/speed post/Courier.
2. The vehicle put to tender will be disposed on the basis of "as is where is" condition along with outstanding tax liabilities if any.
3. The tender papers should accompany by tender cost of Rs.1000/- and earnest money amounting to Rs.1000/- (Rupees one thousand) only per vehicle for no. of vehicles the bidder is interested to bid, in shape of Bank Draft in favor of the Chief District Medical & Public Health Officer, Puri payable at Puri.
4. The intending bidders may inspect the vehicle at the location as above during 10:00 AM to 5:00 PM with prior permission from concerned C.D.M & P.H.O.
