The Quotationers should have valid GST Number (self attested copy of the GST Registration Certificate is to be submitted) and must submit copy showing up-to-date deposit of GST and valid PAN (copy to be submitted).

Each Quotationer shall have to deposit non-interest EMD of **Rs.5,000/-** (Rupees Five Thousand) only in shape of Account Payee / Bank Draft payable to the District Election Officer, Puri which will be refunded to the unsuccessful Quotationers or whose quotations are not accepted on the same day. The EMD of the successful quotationer will be refunded after successful completion of the validity period and the EMD of the unsuccessful quotationer or whose quotations are not accepted shall be refunded on the same day of opening of the quotation . The total offer price per unit shall be inclusive of GST, transportation and installation charges.

The successful Firm / Bidder must sign an Agreement with the Dy. DEO & Dy. Collector, Puri on behalf of the DEO & Collector, Puri for a period of One year from the date of signing of Agreement / finalization of tender and will complete the installation / commissioning and operation of manually operated Fire Alarm System in 7 days unflinching after issue of work order.
