VEHICLE SPECIFICATION & TERMS OF ENGAGEMENT

1. The vehicle will be hired on daily basis.
2. The specifications of rate chart for daily basis of different vehicle has been given below.

1	Standard Truck	Rs. 1900/-
2	Mini Truck (GVW up to 7,500 Kg.)	Rs. 1200/-
3	TATA Ace/Force/Mahindra Minidor (GVW up to 2,000 Kg)	Rs. 850/-

3. The mileage of kilometer per liter of fuel will be mentioned after obtaining the specification certificate from the MVI, Puri.
4. The lowest price bidded will be selected in the tender process.
5. Truck type 4 wheeler and 6 wheeler with permissible loading capacity.
6. The vehicle must be in road worthy condition, must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Road permit, Proof of up to date tax payment, PUC certificate etc. which are mandatory for plying of vehicle.
7. The Driver must have a valid Driving License for driving heavy transport goods carrier vehicle and should be sufficiently experienced in driving heavy transport vehicle.
8. The interested bidder should have to submit a Bank Draft in favour of undersigned for the Rs. 5000/- (Rupees Five Thousand) only which will be accepted on finalization of tender till completion of the period. The above draft will be returned to the unsuccessful bidders instantly.




