



TERMS AND CONDITIONS OF SEALED TENDER CALL

FOR SUPPLY OF SPORTS EQUIPMENTS FOR DISTRICT SPORTS OFFICE, PURI

For The Financial Year-2021-22

1. The Quotationers are to submit their tenders in separate sealed covered envelopes for technical bid & financial bid by super scribing Cover 'A' (Technical Bid) & Cover 'B' (Financial Bid) and both the covers shall be put into a third cover, which should be super scribed as '**Tender For Supply Of Sports Equipments to District Sports Office, Puri for the year-2021-22**'.
2. The Financial bid will be opened only of those bidders who have qualified in the technical bid & submitted as per format with signature & Seal.
3. The rate will be valid for the financial year 2021-22 from the date of approval.

Envelop-A (Technical Bid) –Documents to be submitted

1. The quotation must have an attested copy of valid GST Certificate.
2. Self attested photo copy of PAN Card and Aadhar Card.
3. Total turnover of an amount, more than Rs. 50.00 Lakhs of the tendering firm by last preceding 3 (three) financial years duly certified by a chartered accountant.
4. Attested photo copy of Dealership Certificate with Validity up to financial year 2021-22.
5. The Quotationer is required to submit a self declaration in an affidavit (as per **Annexure -II**) that he has not been black listed by any Govt. organization & he has gone through the tender documents carefully and shall accept all terms and conditions therein.
6. The Bid Security declaration form at **Annexure -III** must be submitted.
7. The basic details of Applicant must be submitted on the Letter Head of the Applicant attached in **Annexure -IV**.

Envelop-B (Financial Bid)

1. The quotationers are required to submit the sports equipment catalog should conform to International Sports Federation (ISF) / National Sports Federation (NSF) quality standards wherever applicable quoted by them. Qualitative materials of branded and durable items shall be preferred and will be selected by the purchase committee.
2. The quotationers are required to quote their rate of information & submit in the **Annexure - I**
3. The sealed quotation(s) will submitted through Regd. Post/ Speed post/ Courier addressed to the District Sports Office, Collectorate, Puri and the quotations must reach **by 04.00 PM on 23.06.2021**. The received tender papers will be opened at the office of the Additional District Magistrate (R&R), Puri **on 24.06.2021 by 11.00 AM** in presence of purchase Committee members & authorized persons of concerned firms to remain present.
4. The incomplete quotations shall be rejected by the undersigned without any reason thereof.

5. The quoted rate of the sports items should be inclusive of all taxes & charges i.e. G.S.T packing forwarding and freight etc.
6. The rate will be valid for the financial year 2021-22 from the date of approval.
7. The sports equipment catalog will be examined thoroughly by the purchase Committee and their comments/ recommendation along with the quotation documents shall be placed before the chair person of the purchase Committee for the consideration and approval.
8. The purchase order shall be placed as per actual requirement as well as availability of funds: Order shall be placed with the approved supplier. The selected quotationers should supply the materials to the District Sports Officer, Puri within 15 days (Fifteen days) from the date of issue of supply order, strictly as per approval by the purchase committee. The 4 (four) delivery point details will be informed at the time of Supply Order by the District Sports Officer, Puri.
9. If the supplier fails to supply the material within the stipulated period, the authority has rights to extend / cancelled the supply order.
10. The authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof
11. Dispute, if any, should be within Puri jurisdiction only.
