SHORT TENDER CALL NOTICE

Sealed tender in plain paper is invited from the intending welder-cum-painters for repair of about 1500 nos. of Ballot Boxes covering 330 nos. of SEC Big Ballot Boxes, 295 nos. of ECI Big Ballot Boxes & 875 nos. of Small ECI Ballot Boxes of this district for the purpose of use in ensuing PRIs, Election, 2022. The terms and conditions are laid down as follows.

1. The rate for repairing and colouring etc. of SEC , ECI Big Ballot Boxes is fixed as follows.
 - (i) Gas welding with fixation of the iron sheet, colouring and greasing per each Big Ballot Box = Rs.250/-
 - (ii) Only colouring and greasing per each Ballot Box i.e. SEC& ECI Big Ballot Boxes= Rs.150/-
2. The rate for repairing and colouring ECI Small Ballot Boxes is fixed as follows.
 - (i) Gas welding with fixation of the iron sheet, colouring and greasing per Small Box = Rs.125/-
 - (ii) Only colouring and greasing per each Ballot Box i.e. ECI Small Ballot Boxes= Rs.75/-
 - (iii) All the Ballot Boxes shall be properly cleaned and greased to make it functional.
 - (iv) Colour of all the Ballot Boxes shall be the same and spray painted in Firoza Blue.
 - (v) All the Ballot Boxes (Big & Small) shall be properly painted inside and outside including opening and closing lever.
3. The selected firm (welder-cum-painter) shall repair, colour etc. all the Ballot Boxes within the premises of District Panchayat Office, Puri and shall complete the work (repairing, colouring etc. of all Ballot Boxes) by the date line 10.11.2021 positively.

The Tender paper should reach the District Panchayat Officer, Puri by the date line 28.10.2021 during the office hours. The intending persons should deliver their tender papers in a box kept in the office of District Panchayat Officer, Puri. The same will be opened on dated. 28.10.2021 at 12.00 noon in presence of the Additional District Magistrate(Rev.), Puri at his office chamber.
