

TERMS AND CONDITIONS

1. The sealed tender should reach in office of the CDM & PHO, Puri through registered post/speed post/Courier only.
2. The vehicle put to tender will be disposed on the basis of "as is where is" condition along with outstanding tax liabilities if any.
3. The tender papers should accompany by tender cost of Rs.1000/- and earnest money amounting to Rs.1000/-(Rupees one thousand) only per vehicle for no. of vehicles the bidder is interested to bid, in shape of Bank Draft in favor of the Chief District Medical & Public Health Officer, Puri payable at Puri.
4. The intending bidders may inspect the vehicle at the location as above during 10:00 AM to 5:30 PM with prior permission from C.D.M & P.H.O., Puri.
5. The E.M.D of the unsuccessful tenders will be refunded to them on the day of opening of tender paper.
6. The tender quoting the highest price at above the price fixed by the authority shall deposit 25% of the offset amount with the CDM& PHO immediately on confirmation of the acceptance of tender by the CDM& PHO& the rest amount within 7 days, on failure to make payment, the amount as aforesaid the deposit into the earnest money shall be forfeited and the vehicle will be put into fresh tender.
7. The vehicle will be handed over to successful bidder after making full payment of the accepted tender money.
8. The selected bidder shall remove the vehicle from the site within 7 days of the payment of the money in full. The custody & safeguard of the vehicle shall be responsibility of the bidder& no claim or complaint on that amount shall be admissible.
9. On failure to remove the vehicle within the stipulated time as aforesaid ground rent of 1% of tendered money shall be charged for each day or part of the day till the vehicle is removed from the site.
10. Where the ground rent so charge exceeds the sale price deposited the tender shall cease to have any rights on the vehicle. The amount deposited by him shall be adjusted towards ground rent & the vehicle shall become absolute property of Govt. free from the encumbrances & dispose by fresh tender.
11. The CDM& PHO, Puri in charge of the vehicle as above preserves all rights of rejecting any or all tenders without assigning any reason thereof.
