Department Notification No. 32010/Gen dated 12.11.2013 amended vide GA & PG Department Notification No. GAD-SC-RULES-0037-2017-28621/Gen dated 27.10.2021. They are posted to different offices under Puri District ICDS Projects as indicated against their names. They should join in their new assignment/ post within **a Week** from issue of this Appointment order as mentioned against each failing which their appointment would automatically stand cancelled & they will not claim for any further appointment under this Establishment.

**Term & Condition**

1. The engagement is purely temporary and terminable at any time without notice and assigning any reasons thereof.
2. Their initial appointment period shall be renewed every year subject to satisfactory performance to be evaluated by the Appointing Authority.
3. She/ He shall continue as Initial Appointees for a period of **06 (six) years**. The period of six years shall be counted from the date of her/ his joining in the

- respective post as per the terms & conditions as well as rules prevalent for initial appointees.
4. On the date of satisfactory completion of six years of Initial Appointment period w.e.f. the date of initial joining, she/ he will be considered for regular appointment. On regular appointment she/ he will be entitled to draw the time scale of D.A. and other allowances as admissible in the corresponding pay band.
  5. Basing on their satisfactory performance on completion of each year of service, their consolidated remuneration will be enhanced as per remuneration slab for Initial appointees prescribed in the Annexure appended with GA & PG Department Notification No. GAD-SC-RULES-0037-2017-28621/Gen dated 27.10.2021.
  6. She/ He shall not be entitled to DA, HRA and other allowances except RCM during the period of initial appointment.
  7. She/ He shall abide by the Odisha Civil Services Conduct Rules'1959 and O.C.S. (C.C&A) Rules'1962.
  8. She/ He shall be enrolled under the New Pension Scheme (NPS) from the date of her/ his engagement.
  9. She/ He should submit the following documents at the time of her/ his joining in the post.
    - i) Medical certificate of fitness signed by the Govt. Medical Practitioner not below the rank of Asst. Surgeon.
    - ii) Two character certificates from two different Gazetted Officers.
    - iii) Original Certificate In support of her/ his qualification and date of birth/ caste.
    - iv) Physical Handicapped Certificate (as applicable).
    - v) Oath of allegiance to the Constitution of India.
    - vi) Attestation form in duplicate along with two passport size photographs duly attested by a Gazetted Officer.
    - vii) Certificate to the effect that she/ he has not more than one spouse living in case of married person.
  10. The engagement will stand automatically cancelled, if she/ he does not join in the post within Seven days from the date of receipt of this engagement order.
