The **valid Residential Certificate / Caste Certificate / other requisite documents** furnished during filing of Application Form / **2 number of photographs** must be submitted by the candidates during document verification.

The candidates selected under **Ex-Serviceman** category are directed to bring their **original Discharge Certificate and ID card** for verification. Besides, he/she will give **an undertaking to the effect that he/she has not already availed any re-employment in Govt. services.**

The candidates selected under **Sports Category** must produce their **original ID card and the sports-person Certificate issued by the Director of Sports, Govt. of Odisha.**

The candidates selected under **PWD** category will produce **their original Disability Certificate.**

Further, the candidates shall have to submit their filled-in **Biodata Form** completely as prescribed & enclosed at **Annexure-B.**

No further date for verification of the documents shall be entertained after 15.12.2021.
