Whereas, the draft notification bearing No. 12 dated the 03.01.2022 was published in Form XXI of the Odisha Municipal(Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 inviting objections and suggestions from all persons interested in respect of the said draft notification showing the division of the area of the **Nimapara Notified Area Council** into wards and reservation of seats thereof on or before the date of expiry of the period of ten days;

\*And, whereas, no objection or suggestion has been received within the period so specified;


Now, therefore, in exercise of the powers conferred by sub-section(3) of Section 12 of the Odisha Municipal Act, 1950 (Odisha Act, 23 of 1950), the District Magistrate, Puri do hereby divide the area of the said **Nimapara Notified Area Council** into **11** wards as specified in Column (2) of the Statement -I below with the description and boundaries of the said wards against each in Columns(3) and (4) respectively thereof for the purpose of ensuing election of Councillors to the same and determine the Wards as specified in Column (2) of the Statement-II below in which the seats reserved under Section 11 of the said Act shall be set assigned against each in Column(3) thereof.

Any person aggrieved by the orders passed by the District Magistrate under sub-rule(4) of rule-2-A may file an appeal before the State Government under the second proviso to sub-section (3) of Section 12.
