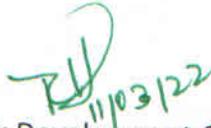

1. The vehicle must be in Road worthy condition, shall not be more than three years old from the date of initial registration and must have valid registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, Pollution free certificate, proof of up to date tax payment etc. which are mandatory for applying of vehicle.
2. The driver of the vehicle must have a valid license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. The monthly rate of hire charge should be quoted separately in the general bid information (excluding fuel and lubricants).
5. The vehicle must achieve a fuel efficiency of 10 Kms per litre.
6. The details of the make and year of manufacture of the vehicle, registration No., Mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation / tender (Annexure-III).
7. The application form of quotation containing General bid information and Terms and conditions for hiring of vehicle is available in the office of the undersigned.

8. The quotation completed in all respect should reach the undersigned on or before 21.03.2022 by 1.00 P.M and shall be opened on the same day at panchayat samitit Pipili by 3.30 P.M. In presence of the bidders or their authorized representatives.
9. The eligible bidder shall commence the service from the date of placement of the order shall continue to provide the service upto one year and it may further be extended after fulfillment of certain conditions.

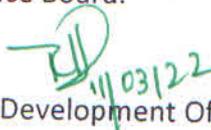

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly basis.

1. The hired vehicles, during period of contract shall have all necessary valid MV documents such as valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. / and Driving License of the driver available all the times. The department / office hiring the vehicle shall not be responsible for any damage / loss caused to hired vehicle of losses of life / injury to any person or damaged to any property on account of use of hired vehicle any manner whatsoever, the hirer shall not be responsible for all such litigations.
2. The hire charges to be paid after deduction of income tax or any other tax applicable by law for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of Engine, Gear box & differential coolant, Tyres & Tubes, battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of the vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
5. In case of vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other sources.
6. The vehicle shall report for duty for minimum 26 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of the hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursement towards cost of diesel (as per actual) and lubricants (as per Govt norms) of selected bidder will be paid in every succeeding month as far as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case of service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination the agreement.

12. All or any tender (or bids) submitted can be rejected without assigning any reasons thereof. No claim, whatsoever, shall be admissible for the alleged loss / damage suffered by the bidders on account of such rejections.
13. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
14. The merit list will be prepared on the basis of quotation received and final selection will be made by the tender committee.
15. The application form must be signed by the vehicle owner or bidder and properly sealed and also attached all relevant documents including drafts as the terms and conditions.
16. The authority will not be responsible for any minor or major repair of the vehicle.
17. The owner of the vehicle should not be reluctant to send the vehicle to rural areas of the Block.
