The quotations completed in all respect should be submitted to the Chief District Veterinary Officer, Puri At/Po- Ghodabazar, Station road, Puri Pin:-752002 by speed post on or before 24.05.2022 at 3 p.m. which will be opened on the same day at 3.30 p.m. by the committee in the presence of bidders or their authorized representative if any. The quotation received after the schedule date and time will not be entertained.

The Bidder should submit their technical bid & financial bid in two separate envelopes duly sealed and superscribed as "Tender for technical & financial bid" for supply of medicines .

1. The participating bidder should quote the medicines as above of reputed brands only.
2. The participating bidder who has been black listed by the state/ Central Govt. or any PSU is not eligible to participate in this procurement process through tender.

Terms & condition of Tender:-

1. The application should be made in separate covers for technical and financial bid. Tender should be typed without any correction or over writing and each page of tender paper should be numbered.
2. Earnest money amounting to Rs 5000 /- (Five thousand only) in shape of Bank draft in favour of CDVO, Puri on Puri should be enclosed.
3. Payment shall be made after delivery of items in good condition as per the specification and only after examination of the consignment by the technical committee.
4. The firm should submit Income Tax return for last 3 years along with up to date GST & other tax clearances .
5. The firm has to quote the price of the medicine separately unit wise as per the format enclosed.
6. The legal matter will be entertained only in Puri Jurisdiction.

7. Medicines supplied should not have expiry date less than one and half year.
8. Supply should be made to the O/o CDVO puri within 15 days after receiving supply order falling which the order will be treated as canceled and the EMD deposited will be forfeited.
