EXPRESSION OF INTEREST FOR EMPANELMENT OF GOLDEN GRASS PRODUCER GROUPS/ARTISANS/SUPPLIER FOR SUPPLY OF PROCESSED GOLDEN GRASS FOR SANKALP KENDRAPARA PROJECT

Willingness is invited from Golden Grass Producer Groups / Artisans for supply of Golden Grass for programs under SANKALP Kendrapara Project. Interested Golden Grass producer groups/artisans should submit the required documents as mentioned below by **11 A.M. on 19/08/2022.**

The empanelment is for duration of almost 12 months starting August 2022 till July 2023. Interested applicants must adhere to the details mentioned below.

Details

1. Quantity: A total of 350 quintals of processed golden grass has to be supplied. Any individual supplier cannot supply less than 10 quintals of processed golden grass
2. Rate: The quoted rate of 1 kg of processed Golden Grass to be supplied must be exclusive of transportation and distribution.
**The rate is subject to change as per the orders of the authorities if the market conditions change.*
3. Area: All interested Golden Grass producer groups/ artisans must be from Puri district.
4. Quality: Quality parameters for processed golden grass are as mentioned in Annexure A. Supply will be checked on delivery and inferior quality Golden Grass will be rejected by the authorities.

Documents

1. Application Form: A correctly filled out application form in English/Hindi/Odia has to be submitted by **11 A.M. on 19TH August 2022.**
Form Collection Point: Form to be collected from Asst. Director (Handicrafts), DIC Office Campus, Chakratirtha Road, Puri from 10:30 am to 5 pm on working days only.
2. Undertaking: A duly signed undertaking assuring that the producer group/artisan/supplier has not been blacklisted by any government organisation in the past is to be attached with the above document during submission.
Undertaking Collection Point: Asst. Director (Handicrafts), DIC Office Campus, Chakratirtha Road, Puri from 10:30 am to 5 pm on working days only
3. Previous Supply Orders: Previous supply orders from any government organisation for supply of Golden Grass for any program is to be attached with the above documents during submission.
4. Sample Bill: A sample bill copy for supply of Golden Grass is to be attached with the above documents during submission.
5. Adhaar Card Copy

1. Submission is to be made no later than **11 A.M. on 19/08/2022** at O/o-The Assistant Director (Handicrafts), DIC Office Campus, Chakratirtha Road, Puri.
2. Submission is to be made in a sealed envelope.
3. The top of the envelope on the front side is to clearly say the following: 'Expression of Interest for empanelment of golden grass producer groups/artisans/supplier for supply of processed golden grass for Sankalp Kendrapara Project'.
4. The envelope is to be addressed (written on the front) to Asst. Director (Handicrafts), Puri.
