THE CANIDATES / JOB SEEKERS REQUIRED TO FILLING UP OF APPLICATION TO TILL ISSUE OF FINAL REGISTRATION CERTIFICATE INCLUDING VERIFICATION OF CERTIFICATES IS TO BE MADE ONLINE SO AS OBVIATE THE NEED OF PHYSICAL VISIT OF CANDIDATES TO THE EMPLOYMENT EXCHANGE. FOR THE SAID PURPOSE CANDIDATES ARE REQUIRED TO LOG IN - empmissionodisha.gov.in AND THEN CLICK TO Directorate of Employment, Govt. of Odisha.

IN THIS REGARD THE CANIDATES REQUIRED TO UPLOAD THEIR ALL CERTIFICATES AND DOCUMENTS ALONG WITH UNDERTAKING / SELF DECLARATION IN THE EXISTING ONLINE SYSTEM MEANT FOR EMPLOYMENT REGISTRATION.

A MECHANISM IS BEING DEVELOPED SO AS TO ENABLE A CANDIDATE TO TRACK STATUS OF HIS/HER APPLICATION.

Sub: Dispensing with the need of physical visit by Job seekers/candidates to Employment Exchanges for employment registration.

Madam/Sir,

Under the State Reform Action Plan-2022 conceptualized in line with the Business Reform Action Plan-2022, it is envisaged to make the public services more user friendly so as to ensure ease-of-living for the citizens of the State. As such it has been decided to do away with the need of physical visit by job seekers/candidates to Employment Exchanges for employment registration to make the service in consonance with the requirements of SRAP-2022.

The following procedures/changes are being incorporated in the existing online system meant for employment registration;

- (i) The entire registration process starting from filling up of application to issue of final registration certificate including verification of certificates is to be made online so as to obviate the need of physical visit by job seekers/candidates to Employment Exchanges.
- (ii) The candidates shall upload all certificates and documents and mandatorily give an undertaking/self-declaration that all information furnished by him is true to the best of his knowledge and belief and if any discrepancy is found in future he/she shall be held responsible for the same and action against him/her shall be taken by the competent authority.
- (iii) A mechanism is being developed so as to enable a candidate to track status of his/her application.
- (iv) Candidates shall be able to download the final digitally signed registration certificate within the stipulated time as per the ORTPS Act.


In view of the above, it has been decided to do away with the off-line mode of registration in any form so that candidates will not be required to make physical visit to Employment

Exchange with effect from 15th October 2022. Besides you are also required to take the following steps on a priority basis:-

- All RADEs and DEOs should take steps for digitization of all legacy data pertaining to their sub-offices / UEIGBs gradually with their existing staff. This process should complete by 31st December 2022
- To avoid immediate dislocation and any unrest by the candidates, wide publicity about doing away with physical verification/presence of candidates may be made. Till this message is widely circulated with the general public, candidates coming to the Employment Exchanges where registration of candidates is made through on-line mode may be allowed to do so and the same may be stopped gradually in due course.
- Steps shall be taken to switch over to on-line mode of registration in UEI&GBs for which RADEs may submit proposal. However considering the constraint of staff, the same may take some time. As an interim measure, candidates may be advised to do their registration in the on-line mode in their respective District Employment Exchanges. As a temporary measure, if these candidates/job seekers visit their District Employment Exchange, they may also be assisted for registering their names through on-line mode. NIC is being requested to make necessary provisions to allow these candidates to register their names in the respective District Employment Exchanges.
- Till the option of digital signature of RADEs/DEOs/EOs in the Registration certificate is integrated and available in the portal, a computer generated Registration Card shall be downloaded by the candidates/Job-seekers with a remark containing " This is a computer generated Registration Card and requires no signature."
