5. No items once disposed to the successful bidder, shall be taken back by Zilla Parishad, Puri.

The successful bidder has to make full payment in the form of Cash/ Demand Draft/ Pay Order of any Nationalized/ Scheduled commercial bank drawn in favour of Chief Development Officer -cum- Executive Officer, Zilla Parishad, Puri and payable at Puri within two days after confirmation, failing which the offer may be withdrawn/ cancelled and EMD shall stand forfeited. The EMD of successful bidder shall be refunded without any interest only after disposal of the vehicle.

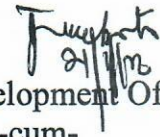
