### AUCTION NOTICE



In pursuance of order No.12130/Dev-II Dtd.19.11.2022 of R.D.C (CD), Cuttack, the office of the Tahasildar Satyabadi has decide to sale / dispose off one (1) condemned Vehicle through the Public Auction on 16.12.2022 (Friday) at 11.30AM onwards, Venue-Tahasil Premises of Satyabadi Tahasil, Kadua, Sakhigopal as per the Following Terms and Conditions: -

1. The vehicle will be sold on "As is where basis is". The auction process will be conducted by auction committee of the office. Taxes and duties that may be levied by Govt. will be extra applicable.
2. The bidder may inspect the said vehicle from 01.12.2022 to 09.12.2022 on working days from 10.00am to 04.00Pm. Interested person may also visit the District web site Puri.
3. Every intending bidder will have to register themselves by way of depositing Rs.1000/-(One thousand) in terms of cash in public auction at least 30 minutes before the scheduled time of auction i.e from 10.00Am to 11.00Am of 16.12.2022 which shall be subject to refund immediately except in case of the highest offer accepted by the competent authority.
4. The successful bidder shall have to deposit 25% of Payment against their bid as soon as the bid is over. In case of failure to deposit the 25% amount after adjusting the security money on the spot. If highest bidder does not accept the offer of the sale vehicle for any reason whatever it may be and withdraw from bidding, the EMD deposited by such bidder will be forfeited. The Committee reserve the right to taken up for re-auction of the vehicle on the same day. The officer of this office and their family members shall not be permitted to participate in the auction.
5. The vehicle will be delivering only after the receipt of full payment and has to be lifted within 07 days of completion of deal falling which ground rent at the rate of Rs.500/-per day will be charged.

6. The person authorised by the bidder will be allowed to take the delivery and for any other liability for using this vehicle for commercial or any other purpose after sale.
7. The vehicle shall not be delivered to the bidder/tenderer until after full payment and compliance with the requisite formalities. Tools, implements and spare parts shall not be delivered with the vehicle.
8. Once release order issues, this office will not be responsible either for safe custody or any loss or damage to the subject vehicle.
9. The highest bid once accepted is not transferable to anyone. In case the bidder is a company, the name of the company should be indicating as the bidder. In case such cases the persons appearing for the company should have the authorisation letter in a proper format issued from a competent authority of the company. Request to change the name of bidder in the tender after submission of the tender will not be entertained.
10. The decision of the auction committee for all the purpose shall be final and binding.
11. The Chairman -cum-Tahasildar Satyabadi reserve the right to reject any or all the tenders without assigning any reasons. The chairman also reserves the right to withdraw the said vehicle from the tender/auction without assigning any reason thereof. 
