Terms & Conditions:-

- The Sale and Receipt of the Bid documents shall available from the office of the BDO, Kanas from Dt- 05/12/2022 to Dt- 20/12/2022 and closed on Dt- 22/12/2022 during the office hours (Except Sunday and Holidays) on payment of cost of bids documents in shape of Demand Draft (non-refundable) issued from any Nationalized Bank drawn in favour of the Block Development Officer, Kanas payable at Kanas.
- The sealed bid documents are to be delivered in the tender box having identification No. B.D.O (Kanas) and shall contain signed DTCN attested copy of Registration Certificate, PAN Card, valid VAT clearance certificate, no relation certificate, document required as per the relevant clauses of the DTCN and special condition if any required amount of EMD in shape of NSC / KVP / POTD / Bank Deposit Receipt of any Nationalized Bank duly **pledged in favour of Block Development Officer, Kanas**. Without which bid will not be considered. The tender can also send their tender papers through Registered Post / Speed Post to Block Development Officer, Kanas. Such bids must be received on or before stipulated date & time as mentioned above. The authority will not be held responsible for the postal delay if any or non-receipt of tender documents in time. The bidders are not required to write their name on the outer cover of the bid but they are requiring writing the name of work with name of office from which bid document was issued.
- The Engineering contractor desiring of having EMD exemption benefit must have to produce an affidavit to the effect that, they have not availed such exemption for more than three times during this financial year. Also the engineering contractor will produce his/her Original license at the time of opening of tender so that the tender opening authority will enter the exemption of EMD in his/her license failing which tender liable for rejection.
- The bid received will be opened on Dt- 23/12/2022 at 12:00 pm in the office of the Block Development Officer, Kanas in the presence of bidder or their authorized agents wish to attend. If the office happens to be closed on the date or receipt / opening of the bids as specified, the bids will be received / opened on the next working day at the same time & venue.
- Other details can be seen in the bidding documents. The bid should be duly filled & signed by the tenderer.
- Special Clause: Additional performance security shall be deposited by the bidder when the bid amount is unbalanced i.e. less than 15% of the estimated cost in such an event the bidder shall deposit the additional performance security to extend of the differential cost of bid amount & the estimated cost in shape of **fixed deposit receipt of Schedule Bank / Kissan Vikas Patra / Post Office Saving Account / N.S.C. / Post Office Time Deposit Amount**, duly pledged in favour of Block Development Officer, Kanas, self-attested copy of Caste Certificate issued by competent authority in case of SC, ST contractor deserving of preference along with the bid document failing which the bid will be summarily rejected.
- The work should be completed within the stipulated time period as mentioned against each tender column & in no case the time extension shall be allowed except the reason not attributable to contractors.
- In order to ensure that the envelopes are properly sealed, the contractor can seal them with super-glue & also add tamperproof tapes as additional precaution. The tender submitted in the wrong works shall not be taken into consideration.
- The authority reserves the right to reject or cancel any or all the bids without assigning any reason thereof.
