The envelope carrying the bid/tender must be super scribed in capital letter with (OFFER FOR AUCTION SALE FOR VEHICLE)

The intending tenderers are advised to inspect the above vehicle parked in the premises of ICDS ICDS Project Puri Municipality in between 10.30 A.M to 5 P.M on any working day before submitting the tender. Each tender must accompany an earnest money deposit of Rs.1000.00 (Rupees One thousand) only in shape of Bank draft of any Nationalized bank in favour of District Social Welfare Officer, Puri which will be refunded to the unsuccessful tenderers , except of successful tenderer. The Govt. in W&CD Deptt. have fixed the auction sale of the vehicle to Rs. 25000.00. The bid/tender price offered shall not be less than the price fixed by the Govt.

The tender should reach the undersigned by registered post/speed post or by hand from 03.12.2022 up to 23.12.2022 by 5.00 P.M at the latest. The tender paper received shall be opened by the Auction sale committee in the office chamber of District Social Welfare officer, Puri on 27.12.2022 at 10.30 A.M in the presence of the tenderers or their authorized representatives. The undersigned will not held responsible regarding late submission /receive of tender in any manner.

The highest tenderer, whose tender will be accepted, shall deposit immediately 25% of the offered amount as initial deposit. He/she shall deposit the balance amount within 7 days of the disposal of the vehicle whichever is earlier. In case he/she fail to make deposit of the total amount as per the tender within stipulated time, the deposit including the earned money shall be forfeited. The EMD of successful bidder can be adjusted at the time of final payment of the tender value in time.

VAT and GST as admissible shall be paid on the bidding/tender cost by the successful bidder/tenderer.

The successful bidder/tenderer shall take permission and remove the vehicle from Satyabadi ICDS Project campus within 7 days and disposal of the bid amount. On failure to remove the vehicle within the aforesaid time span ground rent @ 1% of the tendered amount shall be charged for each day and the part of the day till removal of the vehicle from the aforesaid place. If the ground rate so charges exceed the sale price deposit, the tenderer shall cease to have any right on the vehicle and the amount deposit by him shall be adjusted towards ground rent. Tools implements spare parts shall not be delivered with vehicle.

The authority reserves right to reject any or all tenders without assigning any reason thereof.
