TENDER CALL NOTICE

Sealed tender both technical & financial bid are invited for providing vehicle of required specifications for "MOBILE VETERINARY UNIT" to be engaged in 11 no's Block in Puri District on Monthly Basis as per the revised Guidelines 2022-23, F & ARD Department Letter No.16333 /FARD Dt.17.12.2022. A sum of **Rs. 5000/- (Rupees Five thousand)** only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of **Chief District Veterinary Officer, Puri** and submitted along with the tender as security deposit. After completion of tender process, the Bank Draft will be refunded to the unsuccessful bidders. The sealed tender should reach to the undersigned on or before 11.01.2023 by 02.00 PM. The tender will be opened on same day at 04.00 PM in presence of the bidders or their authorized representatives. The undersigned reserves all rights to reject or cancel any or the tender process without mentioning any reason there off. The vehicle owner will provide a good driver along with MVU assistant as per the following terms & conditions given for engagement for MVU vehicle.

VEHICLE SPECIFICATION & TERMS OF ENGAGEMENT

1. Preferable the vehicle BS - IV compliant petrol vehicle (TUV 300/Bolero/ Sumo Gold/ Ertiga) to avoid pollution through use of diesel vehicle and it should accommodate minimum three persons with all need based equipments, medicines, chemicals, biological etc.
2. The vehicle shall be good condition and shell not be older than three (3) years at the time of quote, minimum average mileage is 10 kms per litre.
3. The monthly hired charges limited to Rs. 31,000/- per month without fuel with maximum fuel charge limit Rs.11,500/- basing on the odometer reading used for actual MVU tour purpose.
4. The vehicle must have valid commercial registration certificate, Road Permit, Insurance, Fitness and pollution control certificate.
5. In case any major break down, the owner has to provide an alternative vehicle of same specification without compromising the services of MVU which should not exceed more than 15 days
6. The vehicle owner will give his consent for stickering of vehicle to be engaged as per the government guideline.
7. The maintenance of the vehicle shall be the responsibility of the owner of the vehicle.
8. No extra charges will be paid for night halts at out station and the lodging/boarding charges of the driver will be borne by the owner of the vehicle.
9. The vehicle will be stationed at the disposal of the DD/BVO preferably Block Head Quarter i.e. Veterinary Dispensary campus.
10. The hired vehicles cannot be use for any private/commercial purpose beyond the official hours.
11. The vehicle owner will go for an agreement for one year and to install GPS tracking device for monitoring and supervision of MVU programme as per the government guideline.

TERMS & CONDITIONS FOR DRIVER TO BE PROVIDED BY VEHICLE OWNER

1. The driver of the respective vehicle must have valid License. He should be non- alcoholic and well behaved person
2. In case, absence of driver for whatever reasons, the owner shall arrange substitute for the Vehicle of same specification.

TERMS & CONDITIONS FOR MVU ASSISTANT TO BE PROVIDED BY VEHICLE OWNER

1. The engagement of MVU Assistant by the vehicle owner will be purely temporary & will be terminated at any time without any notice.
2. Engagement of MVU vehicle will be done each year and accordingly the vehicle owner will provide MVU Assistants every year.
3. The vehicle owner shall provide the MVU Assistants in consultation with the concerned BVO and CDVO as per the below mentioned point.
 - A candidate falling in the below mentioned categories and below 60 years of age, will be given preference in the following order to work as MVU Assistant.
 - A. Candidate having qualification of Diploma in Animal Science.
 - B. Candidate having qualification of +2 Vocational in Animal Husbandry allied subject like Dairy Science, Poultry Science etc.
 - C. Candidate work as Gomitra.
 - D. Candidate work as Pranimitra.
 - E. Candidate having qualification of +2 any stream.
 - F. Para Vets trained in LITCs (below 65 years of age)..




