Sealed quotation are invited from interested reputed agency for drone survey area approx. 55 Kms per day 3 times using to ascertain the illegal prawn Net/Earthen gherries in Chilika Lake of this Tahasil. The following terms and conditions on daily hiring basis as per instruction of Collector, Puri vide letter No .102/Judl. Dt. 11.01.2023 and No 1010 Dt.04.04.2023 to comply the direction of Hon'ble Court passed in WPC No.7469/2017.

Terms and Conditions

1. The drone survey of unauthorized illegal prawn Net/Earthen gherries will be done 3 times in a day and started from 9 A.M to 12 P.M, 1 P.M to 2.30 P.M and 3 P.M to 5 P.M in a day and covered 7 R.I Circles approximate 55 Kms.
2. The reputed Agency should have done drone to about surveillance for a period of 7 days on trial basis continuously and that will be started from May 1 to May 10, 2023 positively. The contract may be extended beyond 7 days.
3. The price should quoted for daily basis including man power all packages, transportation , all cost etc. be borne in hire charges.
4. Drone surveillance of the whole coast of Chilika under Krushnaprasad Tahasil 3 times a day including hiring charges i.e manpower transportation and taxes.
5. Daily cost / price per day including all charges.
6. Interested party should have produce valid GST registration and PAN Card.
7. To cover the whole Chilika coast, drone surveillance will be approx. 55-60 Kms.
8. Video footage will be given to the undersigned . This should be in good quality and visible and recognizable .
9. The agency should have deployed adequate number of drones to cover the whole coast Chilika of Krushnaprasad Tahasil for drone surveillance 3 times in a day.
10. The last date of submission of sealed quotation is on or before 27.04.2023 by 5 P.M. The sealed quotation will be opened on 28.04.2023 by 9 A.M in presence of quotation call committee.
11. The drone camera Technician engaged for machine be well behaved, gentle and obedient in nature.
12. The reputed Agency should have produce valid statutory documents along with police clearance certificate from Competent Authority before time .
