2. The intending bidders are requested to deposit Rs. 5,000/- (Rupees Five Thousand) only as E.M.D. in shape of Demand Draft in favour of Project Director, DUDA, Puri payable at Puri. Quotations received without EMD or EMD in a form other than Demand Draft will not be considered at all. EMD money received from the bidders will be returned to unsuccessful bidders without interest immediately after the process of selecting the highest bidder is over.

3. The sealed quotations in **Annexure-A** may be submitted to the Project Director, District Urban Development Agency, Puri on or before Dt. 02 / 05 / 2023 by 3:00 PM. The quotations will be opened on the same day at 4 PM.

4. Quotations received after due date and time will not be accepted.

5. No items once disposed to the successful bidder, shall be taken back by DUDA, Puri.

The successful bidder has to make full payment in the form of Cash/ Demand Draft/ Pay Order of any Nationalized/ Scheduled commercial bank drawn in favour of Project Director, DUDA, Puri and payable at Puri within two days after confirmation, failing which the offer may be withdrawn/ cancelled and EMD shall stand forfeited. The EMD of successful bidder shall be refunded without any interest only after disposal of the vehicle.

7. The upset price of the tender of Vehicle No. OD-13E-3017 is Rs. 40,000/- (Rupees Forty Thousand) only and Vehicle No. OD-13E-5919 is Rs. 40,000/- (Rupees Forty Thousand) only.


