

TERMS AND CONDITIONS

1. Quotations received beyond the scheduled time will not be accepted.
2. In case of any arrear dues of Municipality stands against the auction holder, the auction will be rejected and the EMD will be forfeited.
3. Highest quotationer has to deposit the bid amount within three days in full and in case of failure the persons/agencies will be blacklisted along with forfeiture of EMD.
4. The quotationer should submit copies of Elector Photo Identity Card, PAN Card, GST Certificate, Aadhar Card in support of his identification and along with application.
5. In no case the request for concession in auction amount will be accepted/considered.
6. The quotationers shall have to pay GST tax of 18% and income tax of 2% on the bid amount.
7. The quotationers shall have to pay statutory dues as per provision of law enforced in state of Odisha on the bid amount.
8. The quotationer must super scribe the name of Parking Place/Shoe Stand/Izra, quotation notice No. with date on the sealed quotation cover, failing which the quotation will not be opened and will be rejected.
