



TERMS AND CONDITIONS

1. Quotations received beyond the scheduled time will not be accepted.
2. In case of any arrear dues of Municipality stands against the auction holder, the auction will be rejected and the EMD will be forfeited.
3. Highest quotationer has to deposit the bid amount within three days in full and in case of failure, the agency or person will be blacklisted along with forfeiture of EMD.
4. The quotationer should submit copies of Elector Photo Identity Card, PAN Card, GST certificate, Aadhar Card along with the application.
5. The quotationer must have at least one year of experience in similar nature of assignment or event management.
6. In no case, the request for concession in auction amount will be accepted/ considered.
7. The quotationers shall have to pay statutory dues as per provision of law enforced in state of Odisha on the bid amount.
8. The quotationer must subscribe the name of Mahal, quotation notice number with date on the sealed quotation cover.
9. The Temporary stalls to be erected from Badasankha to Gundicha Temple on the edge of both sides of road in consultation with Executive Officer, Puri Municipality. Amin, Puri Municipality shall demarcate the space prior to erection of stall.
10. The bidder shall install stalls from staring pint of Red Cross Road Bus Stand entry Gate and Bholanath School 2nd Gate to Nirbani Lane (excluding the frontage of the lane connecting to Grand Road).
11. The quotationer shall not have criminal antecedent.
12. The quotationer shall not be blacklisted by any Government or Public Sector Undertakings (PSU).
13. The quotationer shall not have record of default in payment of statutory dues and compliance of laws.
14. The quotationer shall submit an affidavit regarding Point No. 10, 11 & 12 with an undertaking that in case of submission of wrong information, the EMD amount will be forfeited and necessary legal action will be taken against the quotationer.
