The quotations thus received shall be opened on the **same day at 5.00 PM** in the Tourist Office, Puri in presence of quotationers or their authorized agent only. The quotations must be accompanied with **₹ 20,000/-** (Rupees Twenty thousand) only in the shape of DD drawn in any of the Nationalised Bank in favour of Tourist Officer, Puri as EMD which is refundable.

Terms & Conditions

- The tender holder must have previous experience in participating Tourism Stall/Tourism Exhibition/Tourism Events & submit the copy of the work order confirming execution of similar work.
- Up to date GST certificate, PAN Card, I.T return of last assessment report
- Minimum annual turnover of Rs.5 lakh per year.
- The lowest quotationer/bidder shall be entitled to execute the work.
- The quotationers/bidders must submit the design of the stall as per the specification with all details shall accompany the tender papers in shape of photographs etc.
- The party has to bear the cost of space & energy rent if any.
- The A.D.M (Revenue), Puri, Chairman of the Tender Committee reserves the right to accept, reject any or all quotations without assigning any reason thereof.


