

QUOTATION/TENDER CALL NOTICE FOR HIRE OF VEHICLE

Sealed quotations/tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 1(one) no. of Non AC Bolero Diesel driven vehicles having seating capacity not more than five including driver which shall confirm to the terms and conditions (Annexure-II) for official use in ICDS Project, Pipili on monthly/daily rent basis.


1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. Which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. A sum of R. 5,000/ shall be deposited by the intending bidder in shape of Account Payee Bank Draft drawn in favour of the 'Child Development Project Officer, Pipili 'and submitted along with the tender as security deposit. After completion of the tender process the amount will be refunded to unsuccessful bidders.
5. The monthly/daily rate of hire charge is quoted separately in the general bid information (excluding fuel and lubricants).
6. The vehicle must achieve the fuel efficiency of 10 Kms per litre.
7. The details of the make and year of manufacture of vehicle, Registration no., mileage (Kms covered per litre) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information with the Quotation/ Tender (Annexure – III).
8. The Quotation completed in all respect should reach the undersigned on or before by 03.07.2018 and should be opened on the same day at 2.30 PM in presence of the bidders and Sub- Collector, Puri.
9. The application form of Quotation/ tender containing bid information & terms and conditions for hiring of vehicles etc. will be available with the office of the Child Development Project Officer, Pipili on payment of Rs.100/- from 26.06.2018 to 03.07.2018 .
