
The rate should be quoted as "per day" including labor charges and materials and other taxes/charges.

The quotation should reach the undersigned on/before 30.08.18 by 5 PM and the same shall be opened on 31.08.2018 at 11 AM in the office chamber of CDMPHO, puri in presence of the quotationers or their authorised representatives. The authority reserves full right to accept or reject any or all quotations without assigning any reason thereof.

TERMS & CONDITIONS


1. The quotation should be properly sealed with insignia and be superscribed as quotation for lifting of general waste.
2. Attested copy of valid VAT/PAN/GST registration from the competent authority shall be attached with the quotation.
3. The rate for lifting of general waste shall be quoted "per day" including all charges and taxes.
4. No extra cost shall be given towards the lifting.
5. Alternatively 2 trolleys shall be kept in the premises of DHH, Puri at the said location for the storage of the general waste one after another. The general waste shall be lifted and disposed immediately as & when required after the trolley is filled; so that no waste is left on ground
6. The agency or person shall maintain a logbook for the details of the trips lifted which shall be countersigned by DMO-cum-Superintendent.
7. The collection and transportation of the general waste shall be carried in a manner to avoid any possible hazard to the environment.
8. In case of deficiency in providing quality service, the authority has the right to impose penalty as deemed proper. (In case financial penalty, it shall be deducted from the monthly bill)
9. The contract shall be valid for one year and may be extended, subject to satisfaction of the performance.
