TERMS AND CONDITIONS.

1. The quotation shall contain monthly hire charges & consumption of lubricant per km by the quotationer in his quotation paper of the vehicles required as below.
2. The vehicle must have registered under MV Act and rules with the valid insurance coverage. The attested copy of the registration no. and insurance copy shall be furnished.
3. The vehicle shall not be more than 2 years of purchase.
4. The attested photo copy of Road permit, Road Tax certificate and Pollution free Certificate shall be furnished.
5. The photocopy of Driving License.
6. The successful quotationers shall execute an agreement in non-judicial paper within a week of finalization of quotation.
7. The vehicle and driver shall remain under full responsibility of the owner without any responsibility of the District Project Office.
8. Servicing, Maintenance, repair as and when required shall be borne by the owner at his own cost.
