QUOTATION CALL NOTICE


Sealed quotations in plain paper are invited from intending authorized Firms / Agencies having valid GSTIN, PAN number for installation of CCTVs on hire basis for conduct of written examination for the post of Asst. Section Officer scheduled to be held on 23.12.2018 in 130 examination Halls at 12 different examination centers located at Puri district Head quarters. Approximately 260 CCTV cameras @ 2 per each Hall are to be installed for close vigilance of the proceeding of the examination. The quotationers are informed to quote their rate per day per Camera & put the quotation in the Drop Box in the District Establishment Section, Collectorate, Puri on or before 30.10.2018 by 2.00 PM and it will be opened on the 30.10.2018 at 3.00 PM by the Committee duly authorized by Collector, Puri. The quotationers or their authorized agents should remain present at the time of opening of the quotation on the date & time fixed at Dist. Establishment Section, Collectorate, Puri. Negotiation may be made for finalization of rate with the quotationer. The total offer price per unit shall be including of GST, transportation and installation charges. The scheduled date of Examination, examination center & number of CCTV cameras may be changed subject to finalisation by OPSC. The selected Agency will submit 03 sets CDs containing the entire CCTV Camera footage of examination process of each hall/room at his own cost.

The quotationers should have valid GST No. (Self attested copy of the GST Registration Certificate is to be submitted) and the quotationer must submit copy showing upto date deposit of GST and valid PAN (copy to be submitted).

Each quotationer shall have to deposit non-interest bearing EMD of Rs.25,000/- (Rupees Twenty Five Thousand) only in shape of Account Payee Bank Draft payable to the Collector, Puri which will be refunded to the unsuccessful quotationers or whose quotations are not accepted. The EMD of the successful quotationer will be converted to security money & the same amount will be refunded after completion of the work.

The undersigned reserves the right to cancel any or all the quotation without assigning any reason thereof. If the quotation cannot be opened due to unforeseen reason, the same will be opened on the next working day at 11.00 AM.




