Each tender must accompany an earnest money deposit of Rs 5000/- (Five thousand) only in shape of Bank draft of any Nationalized Bank in favour of Tahasildar, Pipli which will be refunded to the tenders, whose tenders are not accepted except in case of successful bidder. The bid price offered shall not be less than minimum price as mentioned above.

The tender should reach the undersigned by registered post/speed post or courier from 10.11.2018 to 25.11.2018 up to 5.00 PM at the latest and tender received shall be opened by the Auction Sale Committee in the office chamber of Tahasildar, Pipli on 26.11.2018 at 11.00 AM in the presence of the tenders of their authorized representatives. The undersigned will not held responsible regarding late submission receive of tender in any manner.

The highest tender whose tender is accepted shall deposit immediately 25% of the offered amount then and there as initial deposit. He/she shall deposit the balance amount within 7 days of the disposal of the initial amount. In case he/she fail to make deposit of the total amount as per the tender within stipulated time the deposit including the earned money shall be forfeited. The EMD of successful bidder can be adjusted at the time of the final payment of the tender value in time.


VAT and GST as admissible shall be paid on the bidding cost by the successful bidder.

The successful bidder shall take permission and remove the vehicle from Pipili Tahasil office within 7 days of disposal of the bid amount. On failure to remove the Vehicle within the aforesaid time span, ground rent @1% of the tendered amount shall be charged for each day or the part of the day till removal of the vehicle from the aforesaid place if the ground rate so charges exceeds the sale price deposit ,the tender shall cease to have any right on the vehicle and the amount deposited by him here shall be adjusted towards ground rent,Tools implements ,spare parts shall not be delivered with vehicle.

The authority reserves right to reject all tenders without assigning any reason thereof.




