1. At least 11' high palm leaf log so that 4' can be made under ground.
2. 6' dia fiber Umbrella stay on square bar (heavy) stick molded with fiber.
3. Thickness of the fibre umbrella should be of 4 mm.
4. Shed colour should be dry palm leave colour.
5. Including transportation, installation & all taxes.


