**CORRIGENDUM**

In partial modification of this Office Notice No.649/Niz. dt.10.12.2018 the following addition and alteration are hereby made to the Tender Call Notice for procurement of furniture & fixtures.

The last date for receipt of Tender paper in this office is revised and fixed to dt.09.01.2019 upto 3.00 PM in place of 26.12.2018. It will be opened on dt.09.01.2019 at 4.00 PM.

Para-3 of the Terms and Conditions is revised as "The bidder will furnish their offered rate per unit for the items in Annexure-II. The GST and other charges as applicable must be quoted in separate column."

Para-4 is added with "Vendors having annual turnover of an amount of at least Rs.10,00,000/- (Rupees ten lakh) and at least three years' past experience in successful supply of articles to Govt. Offices will be eligible to participate the bid."

Para-5 is added with "The bidder seeking exemption from depositing earnest money must attach supporting documents. The local MSE bidder, if selected, shall be required to pay 25% of the value of performance Security."

"Steel Table" at Sl. No.3 of Annexure -II is replaced by "Office Table"

Wooden bench, wooden chair and wooden table at Sl. No.9, 10 and 11 of Annexure-II are eliminated.


