

Sealed Tenders are invited from the intending manufacturers/,authorized distributors ,Opticians and GEM,rate Contract holders for supply of spectacles for school children near work old peoples and other items for Puri District..The sealed tenders must be sent through Regd Post/Speed Post/courier service only.The supply should be door delivery & no freight charges should be borne by this office .The rate should be quoted including of all incidental charges but excluding of GST as admissible by the Govt Of Odisha


The tender should reach to the undersigned on or before 30.1.2019 ^{12NOON} upto 5-P.M and the same will be opened on 30.1.2019 at 1 P.M in the office chamber of CDM & PHO, Puri in presence of the tenderers or their authorized representatives. The authority reserves full right to accept or reject any or all tenders without assigning any reason thereof.

Terms & Conditions

1. The Tender should be properly sealed and superscribed as "TENDER FOR SUPPLY OF SPECTACLES AND OTHER ITEMS FOR PURI DISTRICT.
2. Attested Copy of the valid Drug License, VAT Clearance Certificate & GST Regd Certificate should be attached with the tender paper.
3. Tender Cost Rs.500.00(non-refundable) in shape of D.D payable at puri should be attached with the tender.
4. E.M.D Cost Rs.2000.00 in shape of D.D payable at puri should be attached with the tender.The EMD of the unsuccessful bidder will be returned only after finalization of the tender and the EMD will be forfeited if the successful bidder will refuse to supply the indented items.
5. The optician will supply the required spectacles within 15 days of receipt of the order. The optical centres are expected to keep enough stocks of the frame (of different sizes & colours) and the lenses to ensure timely supply of the spectacles to the children.
6. The sample of the spectacles must be send with the tender.
7. If the above specification are not adhered to or the child has been provided wrong lenses as found later by the ophthalmic Asst,the optician will not entitled to receive any payments for such spectacles. He has to provide free replacement if payment has already received. If this happens too often the Deptt can terminate the contract with the optician eve before the expiry of the validity period.
8. Order will be placed according to the indent and availability of funds.
9. Tender paper will be rejected if any of the above documents not submitted with the tender.
