




**TERMS & CONDITIONS OF TENDER FOR Wall Painting under campaign on  
Complementary feeding of NOP,PIP**

Sealed Tender in prescribed forms are invited from the intending registered Firm(s) Govt. or Semi Govt. Agencies/ Cooperative Societies / Advertisers/artists having valid license/experience for painting of 4 nos. of wall paintings in each Gram Panchayat (230 Gram Panchayat areas) of 11 ICDS Projects (11 Block areas) i.e. 920 wall paintings in 230 Gram Panchayat of 11 ICDS Projects (Blocks) of this District

1. "No individual, company, firm, corporation shall participate in the Tender process unless it obtains or possess valid license/experience of Competent Authority
2. The Tender paper should be filled in properly and legible without any cutting/over writing. The rates and units should be written both in words and figures in the Tender paper. The rates quoted (Flat rate per unit inclusive all expenditure, tax, article , journey etc.) should be final and the Tenderer shall not be allowed to change the same under any circumstances. All pages of the Tender paper must be signed by the Tenderer as token of acceptance of the terms and conditions.
3. The Tenderer will submit their bid in sealed envelopes, containing all required documents and be submitted super scribing "WALL PAINTINGs UNDER NOP,PIP"
4. The Tenderer should furnish following self attested documents/ papers along with the Tender (application with tem & conditions) paper. Non-submission of any of the documents specified shall be summarily rejected. The Tenderer shall have to produce the original documents if necessary before the Tender Committee for verification. These documents are to be enclosed serially as per application form .

a)Original Tender paper duly signed by the Tenderer.

b)Original Bank draft towards cost of Tender paper.

c)Earnest money of Rs.50,000/- (Rupees fifty thousand) only in shape of NSC/KVP/Term Deposit duly pledged in favour of District Social Welfare Officer, Puri

d)Up to date Income Tax Clearance Certificate & PAN Card .

e)Attested copy of the license/experience on commercial painting of Competent Authority.

f)Shop &Commercial establishment address with phone No., E-mail, Fax etc.

g) Attach the First page of Bank Pass Book

h) GST registration No.

i) j) undertaking on guarantee for one year.

5. In case the successful Tenderer refuses to execute work of transporting agent after acceptance of his Tender by the undersigned, the earnest money deposited by him will be forfeited.
6. The EMD of Successful Tenderer converted as security deposit after finalization of the Tender. This will be refunded only after 1 year after successful completion of contract period. The whole or part of the security deposit will be forfeited for irregular performance or breach of any of the terms & conditions of agreement during contract period. Earnest Money of un-successful Tenderers shall be refunded after finalization of the Tender. All 920 paintings are to be completed within 3 months from the date of issue of work order from District Social Welfare Officer, Puri and accordingly the tenderer will arrange manpower for completion of all painting at his own cost.
- 7) Tenderer is to paint in 4 locations of each GP areas in respect of 230 GP areas of 11 ICDS/Block areas. & no extra charges will be paid to them (the rate, quoted shall be including all charges to different ICDS Project qtrs. viz. Astarang, Brahmagiri, Delang, Gop, Kakatpur, Kanas, Pipli, Krushnaprasad, Nimapara, Puri Municipality, Puri Sadar & Satyabadi). The list of location for wall paintings will be provided to the selected tenderer just after finalization of tender and at the time of issue of work order by the District Social Welfare Officer, Puri for the purpose.
8. Payment shall be made against submission of bills as per approved rates. The bill should be submitted with digital photos with signature of CDPOs concerned. The photos be submitted with name of the Block/ Gram Panchayat/ Village/ AWC in details in reverse side.  
The District Social Welfare Officer/CDPOs shall check 10% of paintings at their level & DSWO, Puri shall have the right to deduct and adjust any amount found recoverable towards loss and damage or both. All the photos are to be countersigned by the Child Development Project Officers on reverse side of the photos.
9. No advance payments shall be allowed.
10. The Tender Committee will judge the feasible/workable rate of painting to award the Tender. It is not that the Tender will be awarded to the bidder quoting the lowest rate, if the rate is not feasible /workable, The tenderer will submit the specimen copy of the painting of each items in a flex be submitted at the time of opening of tender with duly sign and stamp of the tenderer. All paintings should be made with enamel paint which may continue for a period of 1 year at least. An under taking should be submitted by the tenderer with tender paper in this regard.

11. The Tenderer shall carefully go through all the terms and conditions of the Tender document and submit the Tender papers correctly
12. The lowest rate of the Tenderer can be considered for acceptance if the rate is within the cost norm depending upon the local condition and prevailing prices.
