The proposals/Expression of Interest received incomplete or after the schedule date and time shall not be taken into consideration. The authority reserves the right to reject any or all the proposals without assigning any reason thereof.

1. The shops/vendors must have district presence having Shop/Dealership and Servicing Center in Puri District.
2. The shops/vendors should be registered dealer having valid GSTIN Number. The shops /vendors should have up to date VAT clearance Certificate.
3. The shops/vendors must have filed annual return under GST till last Tax Period and under IT Act for Last Three consecutive years.
4. The shops/vendors should have valid PAN/TAN/GST Number (Attested copies of all above documents are mandatory while submitting proposals / Expression of Interest)

PROCEDURE FOR SHORT LISTING

- i) Application for empanelment will be opened and assessed by the Committee.
- ii) The Committee reserves right to commend amendments in the proposed work.
- iii) The decision of the Committee shall be final and binding on all the bidders.
- iv) Committee reserves the right to select one or more agencies / shops for each item subject to eligibility, compliance to quality, price term etc.

All the proposals, received by due date will be scrutinized to assess their eligibility based on the eligibly criteria in presence of all the applicants. The proposals which do not meet the eligibility criteria will be summarily rejected by the Committee on the said date. Shops / Vendors / Agencies will be shortlisted for the empanelment shall be issued Request for proposal (RPF) for the work.
