

TERMS OF REFERENCE TO THE TENDER PAPER FOR THE ORGANIZATION OF MINA BAZAR 2019 AT OLD JAIL GROUND PURI, NEAR MEDICAL SQ. ARE (IN THE PREMISES OF PALLISHREE MELA) (FROM 3RD TO 13TH JULY, 2019)

I. TERMS AND CONDITIONS:

1. Sealed tenders are invited from experience firms/Agency/ Persons, of taking the Organization of Mina Bazar in a single work order.
2. The bidder has to pay of Rs. 5000/- (five thousand only) towards cost of tender paper which is available in DSMS, Puri or download from website of www.puri.nic.in.
3. The bidders should have won (PAN) Certificate. Copy of the registration certificate of the firm and valid number in favor of the firm from Commercial Tax (GST) and update chalan as on 31th march 2019.
4. Copy of work orders/ experience certificate for similar nature of works in Odisha.
5. The bidder shall quote their price for all the items without leaving blank. If found so, the bid will be treated as non-responsive and rejected.
6. The authority is not bound to accept the lowest tender and reserves the right to inspect/verify the stock of materials required for this work, in Go-down of bidders by nominating a Committee to ascertain the credibility of the firm. Further the undersigned reserves the right to reject any or all tenders without assigning any reasons thereof.

- 20. The final payment will be made on the basis of the actual work done and Work Assessment Report in the specified format by the Mela-in-charge. The bidder shall not use any additional materials other than the work specified in the work order without the prior permission of the Mela-in-charge.
