Sealed tenders are invited from the interested reputed/registered Transport agencies/ Suppliers/Service Providers/firms for supply of 5 Nos of Light Commercial Vehicle - (TATA ACE / MAHINDRA MAXIMO / ASHOKLEYLAND DOST/ PIAGGIO PORTER 700 ) including driver to this office for door to door collection of garbage from households inside (*ULB Name*) Area . which shall conform to the Terms and conditions ( **Annexure-I**) for Official Use in Solid Waste Management.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for applying of vehicle. Self attested copy shall be attached with the bid
2. The Driver of the vehicle must have a valid Driving License for driving of Light Commercial Vehicle and should be sufficiently experienced in driving of Light Commercial Vehicle. Self attested copy shall be attached with the bid
3. The DTCN with detailed term and conditions can be obtained from the Office of the undersigned on payment of Rs 1,000.00 ( Rupees One thousand) in cash (non refundable) or can be downloaded from nac web site [www.nackonark.in](http://www.nackonark.in) Money receipt Or A/C Payee B.C/D.D/B.D for Rs 1,000.00 of any nationalized bank in favour of Executive Officer , NAC, Konark ( In case of download) towards paper cost shall be furnished along with the offer.
4. A sum of Rs 5,000.00 per vehicle shall be deposited by the intending bidders in shape of A/C payee Bank Draft in favour of Executive Officer, Konark NAC and submit the same along with tender as Security deposit After completion of the tender process the amount will be refunded to the unsuccessful bidder.
5. The rate should be mentioned including salary of the driver and vehicle charge per month in the general bid .
6. The Vehicle must achieve a fuel efficiency of 15 Kms per liter. The cost of fuel (as per actual) will be reimbursed every month after submission of Fuel Bill.
7. The details of the make and year of manufacture of the vehicle, registration no., mileage (Kms. covered per litre) and name of the Driver with Driving License No. and period of

validity should be specifically provided in the general bid information to be furnished with the Quotation/Tender (Annexure-II).

8. The Technical Specification of the vehicle is attached at **Annexure-III** for reference and to be strictly followed
9. The Quotation/tender completed in all respect should reach the undersigned on or before Dt.26.08.2019 by 3.00 P.M. in the drop box keep in the office premises and shall be opened on the same day at 3.30 p.m. in presence of the bidders or their authorized representatives.
10. The eligible bidder will be selected on L1 basis..

The eligible bidder shall commence the services from the date of placement of the order and shall continue to provide the services up to 6 months from the date of issue of order and it may further be extended to next 6 Months after fulfillment of certain conditions to the satisfaction of Authority.







## TERMS & CONDITIONS FOR HIRING OF VEHICLES

Annexure - I

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as :- valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. and D.L. of the driver available all the times. The Department/ Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or losses of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hired shall be responsible for all such litigation.
2. The hire charges to be paid after deduction of income tax or any other tax as applicable by law for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty for minimum of 30 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made. All other expenditures of vehicle towards repair, replacement of spare parts, lubricating oil engine , gearbox and different coolant, tyres, tubes, battery etc. will be borne by the contractor.
9. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. The vehicle owner/bidder should apply in one form for all ULB or may specify the ULB for which he may apply and also he can quote the rates separately for each ULB.

13. All or any of the tenders (or bids) submitted can be rejected without assigning any reasons thereof. No claim, whatsoever, shall be admissible for the alleged loss/ damage suffered by the bidders on account of such rejections
14. The customization of the vehicle will be done by the bidder as per the specification corrigendum letter no.1322 Dt.24.08.2019.
15. The Office hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle , any manner what's so ever. The owner shall be responsible for all such litigation.
16. In case of breakdown for reasons what so ever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
17. No advance payment will be made.
18. If the bidder violates any of the terms of contract, the office shall forfeit the entire amount of security deposit.
19. The application form must be signed by the vehicle owner or bidder and properly sealed and also attached all relevant documents including drafts as per the terms & conditions.
