Sealed Tender are invited for auction sale of condemned Mobile Van bearing No. OR-02F-8943 (Ashok Ley Land Cargo- 909) of Odisha State Civil Supplies Corporation Ltd., Puri, on "as is where is basis along-with all available documents". The intending tenderers are requested to submit their tenders in plane paper offering their bids duly sealed along with one Bank Draft worth Rs. 5,000.00 (Rupees five thousand) only as EMD drawn in any Nationalized Bank in favour of District Manager, Odisha State Civil Supplies Corporation Ltd., Puri. The tenderers are required to submit the tender papers strictly through Registered Post / Speed Post / Courier Services. The last date of receipt of tender is dt. 28.10.2019 till 5.00 PM. The tender papers received after the specified date and time as mentioned above, shall not be entertained and the same shall be out rightly rejected. The sealed tenders shall be opened on dt. 29.10.2019 at 4.00 PM in the office chamber of District Manager, O.S.C.S.C. Ltd., Puri in presence of the tenderers or their authorized representative, if they wish. The tenderers may inspect the vehicle kept in the premises of District Manager, Odisha State Civil Supplies Corporation Ltd., Puri during any working day from 10.30 AM to 5.00 PM

The up-set price of vehicle No. OR-02F-8943 has been fixed at Rs. 55,000.00.

TERMS AND CONDITIONS :

1. Tenders should be submitted by super-scribing "Auction Sale of the Vehicle No. OR-02F-8943" on the top of the closed envelope containing the EMD.
2. The tenderer with highest bidding shall be selected by the competent authority. He shall deposit 25% of the bid amount immediately on the spot and rest amount shall be deposited within 7 (Seven) days or at the time of taking delivery of the vehicle, whichever is earlier.
3. The EMD of all unsuccessful tenderers will be refunded to them on the same day.
4. If the prices offered by sealed tenders are found less than the upset price, then competent authority may go for fresh auction sale or negotiation may be made with the highest bidder to fetch the minimum up-set price.

The highest offered value will be sent to Head Office for kind approval. After receipt of approval of MD, the vehicles will be disposed of by observing all other formalities.

5. In case the successful tenderer fails to deposit 75% of balance auction price at the time of taking of delivery of vehicle within 7 days, his / her delivery order will be cancelled and the EMD along with 25% deposit will be forfeited.
6. The highest bidder will remove the vehicle within 15 days of deposit of the total amount, failing which ground rent Rs. 100/- per day will be charged till final removal of vehicle.

7. Registration of the vehicle has already been cancelled by RTO, Puri.
8. If the ground rent so charged exceed the price deposited by the tenderer shall ceased to have any right on the vehicle and amount so deposited by him will be adjusted towards ground rent. The vehicle shall become absolute property of the Corporation free from all encumbrances and it will be disposed of by fresh auction / tender as the case may be.
9. The authority reserves the right to accept or reject any or all the tenders without assigning any reasons thereof.


