Sealed quotations are invited from the interested bidders for auction of non standard paddy seeds of variety CR 1009 Sub-1 (255.40 Quintals) & Swarna Sub-1 (57.40 Quintals) of Kharif-2022 produce lying in Govt. Agril. Farm, Olansa. The interested bidders should submit their auction paper in a sealed cover addressed to the Chief District Agriculture Officer, Puri on or before dt.20.02.2024 by 2.00 PM. The auction papers will be opened on the same date i.e. dt.20.02.2024 at 4.00 PM by the auction committee constituted for the purpose in the office chamber of Chief District Agriculture Officer, Puri in presence of the bidders or their authorized representatives. The interested bidders are to submit their auction papers along with the EMD of Rs.10,000/- through Bank Draft in favour of "Chief District Agriculture Officer, Puri" payable at Puri. The earnest money will be refunded to the bidders after finalization of auction. The offset price per Quintal of non standard Paddy seeds is Rs.2183/-, which is inclusive of cost of HDPE bags. The successful bidder has to deposit the total auction money within 3 days in the office of the Chief District Agriculture Officer, Puri, failing which the earnest money deposited by the bidder will be forfeited. The successful bidder has to lift the entire stock within a week from the date of deposit of the total value at his own cost failing which the earnest money deposited by the bidder will be forfeited. The interested bidders can inspect the stock during office hours at Govt. Agriculture Farm, Olansa. The committee reserves every right to cancel the auction without assigning any reason or shift the time or date of the auction in case of non participation of sufficient bidders.
