
Quotation Call Notice No. 622 /Elec. Dt. 19/02/2024

Sealed quotations in plain paper / letter pad are invited afresh from the intending Firms / Authorized Dealers / Suppliers and Agencies for hiring of **GPS Tracking System** of Four wheeler to be engaged in Simultaneous General Elections-2024.

Terms and conditions of the Quotation Call Notice.

- 1) The Quotationer should have valid GST No. (self attested copy of the GST Registration Certificate is to be submitted)
- 2) The quotationer must submit copy showing up to date deposit of GST.
- 3) The Quotationers should have valid PAN (copy to be submitted)
- 4) Any requirements as desired by the DEO & Collector, Puri, should be supplied by the successful bidder immediately as per local market price.
- 5) The quotationer must arrange sufficient technical persons, if any defect arises at any point.
- 6) The quotationer shall have to furnish their offer (rate) of the items per unit as detailed in the Quotation call Notice and in the enclosed **Format**. The total offer price per unit shall be inclusive of GST, transportation and delivery charges. The price quoted shall be valid for the period of one year from the date of issue of contract or till finalization of process of next Quotation whichever is later.
- 7) The Quotationer shall deposit non-interest bearing earnest money of **Rs.1,000/-** (Rupees One thousand) only in shape of Account Payee Bank Draft payable to the District Election Officer, Puri which will be refunded to the unsuccessful quotationer or whose quotations are not accepted. The EMD of the successful quotationer will be refunded after completion of the validity period.
- 8) The Quotations should reach in the **District Elections Section, Collectorate, Puri on or before 2.00 PM of dated 27.02.2024** and the same shall be opened on the same day at **4.00 PM in the office chamber of Addl. District Magistrate (Revenue), Collectorate, Puri** in the presence of Committee members and Quotationers or his authorized representatives, if they so desire.
- 9) The Quotations received in incomplete form or after the scheduled date & time shall be summarily rejected. The Committee reserves the right to reject all or any quotations without assigning any reason thereof.
- 10) The Tender Committee are not bound to accept the lowest financial bid and reserves the right to negotiate the rates and other terms and conditions with the lowest quotationer.
- 11) On delivery, the products shall be inspected to ascertain the quantity / specification / quality for which the order was placed. If, it turns out to be otherwise, the acceptance or delivery shall be refused and asked for explanation for supplying of such materials.
- 12) Failure to supply the order in full within the stipulated period shall lead to forfeiture of EMD and action as deemed proper shall be taken against the Firm / Agency.
- 13) The successful Firm / Agency must sign an agreement with the District Authority for a period of one year from the date of signing of agreement / finalization of tender and will complete the delivery of items within 5 (Five) days unflinching after issue of work order, failing which the order will stand automatically canceled. The rate of unit-wise item should be quoted distinctively.




