### NOTICE INVITING TENDERS FOR THE WORK

#### NATIONAL COMPETITIVE BIDDING

The OFFICE OF THE PANCHAYAT SAMITI KAKATPUR, Puri, Odisha on behalf of Governor of Odisha invites Percentage Rate Bids in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Single Bid system from Class of Contractors as mentioned in Col.6 of table registered with the State Governments and contractors of equivalent Grade/Class registered with Central Government/MES/Railways for execution of Civil Works requirements given in the DTCN on Percentage Rate Bids to be eventually drawn up in the standard P1 Contract Form. The bid should be submitted offline in the office of Panchayat Samiti Kakatpur by eligible class of contractors. The registered bidders of outside Odisha can also participate in this process, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.

- Mode of Submission of tender: Tender should be submitted offline after depositing the Tender Paper cost in the form of Bank Demand Draft at the Panchayat Samiti Office.
- 2. a) The bidder should make payment through offline receipt towards Tender Paper Cost.

- The bidder should make payment through offline receipt towards EMD through Bank DD.
- The copy of EMD Deposit, Registration certificate, GST, PAN, EPF OR UNDERTAKING FOR EPF & affidavit including all required papers up loaded through website and should be produced in original to the BDO, KAKATPUR, Puri for verification within three days of opening of Bid. Otherwise, the tender will be rejected.

- 4. The bidder shall have to furnish No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
- If rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalized basing on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/ their authorized representatives, the concerned Assistant Executive Engineer and AO will remain present.
- 6. Fixed deposit holders/ Exemption holders by order of Central/ State Govt. will also be required to furnish the requisite security amount along with the bid in the prescribed form, otherwise the bid shall be considered as non-responsive. Similarly, ST/ SC contractors seeking exemption of 50% EMD or price preference required to produce an affidavit to this effect. The ST/SC contractors having Degree/ Diploma in Engineering are not allowed to avail both the benefits. Both Engineering and ST/SC contractors should submit the affidavit in writing regarding the facility to concerned officer inviting tender, otherwise they will not be entitled to get the facility.
- 7. If L1 bidder does not turn up for agreement after finalization of tender, then he shall be debarred in participating in bidding for two years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfills all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
- Goods & Services Tax (GST) will be imposed as applicable.
- Subsequent corrigendum if required shall be appeared in the website. The bidder must provide the mobile no. and e-mail ID along with the tender documents on Cover conducted in accordance with the works department order no. 12366 dtd. 8.11 2013. MOBILE NO/ E-mail ID OF BIDDER along with tender documents. There should be a Separate Envelope inside the Main Envelope for Financial Evaluation.
- 10. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including

recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited

Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
