NOTICE INVITING TENDERS FOR THE WORK

NATIONAL COMPETITIVE BIDDING THROUGH e-Procurement

The **OFFICE OF THE PANCHAYAT SAMITI PURI SADAR, Puri, Odisha** on behalf of Governor of Odisha invites **Percentage Rate Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in **Single Cover** system from Class of Contractors as mentioned in Col.6 of table registered with the State Governments and contractors of equivalent Grade/Class registered with Central Government/MES/Railways for execution of Civil Works requirements given in the DTCN on **Percentage Rate Bids** to be eventually drawn up in the standard **P1 Contract Form**. The bid should be submitted on-line in the website www.tendersodisha.gov.in by an eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before submission of bids. The bid documents will be available on the above website from Dt. 21.08.2024 at 03:00 PM to Dt. 31.08.2024 up to 05:00 PM. For “On-line bidding”. The bidder must possess a compatible digital signature certificate (DSC) of Class-II or Class-III.

1. Mode of Submission of tender: Tender should be submitted online in www.tendersodisha.gov.in
2. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes / modifications / addendum to DTCN if any.
3. a) The bidder should make payment through online receipt towards Tender Paper Cost. No offline receipt of Tender Paper Cost will be allowed in e-procurement portal of Government of Odisha.
b) The bidder should make payment through online receipt towards EMD. No offline receipt of EMD will be allowed in the e-procurement portal of Government of Odisha.
c) The scanned copy of Tender Paper Cost, EMD Deposit, Registration certificate, GST, PAN, EPF Registration OR UNDERTAKING FOR EPF & affidavit including all required papers uploaded through website and should be produced in original to the **BDO, Puri Sadar, Puri** for verification within three days of opening of Bid. Otherwise, the tender will be rejected.

6. The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of bids. If any Bidder / Tenderer withdraws his bid/ tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.
7. The bidder shall furnish a No relation certificate along with the bid documents to the effect that no officer of the Department to the rank of Assistant Engineer or above is related to him.
8. If the rate quoted by a bidder is less than 15% of the tendered amount, then such a bid shall be rejected and tender shall be finalised based on merits of rest of bids. But if more than one bid is quoted up to 14.99% (Decimals up to two numbers will be taken for all practical purposes) less than the estimated cost, the tender accepting authority will finalise the tender through a transparent lottery system where all bidders/ their authorised representatives, the concerned Executive Engineer and AO will remain present.
9. Fixed deposit holders/ Exemption holders by order of Central/ State Govt. will also be required to furnish the requisite security amount along with the bid in the prescribed form, otherwise the bid shall be considered as non-responsive. Similarly, ST/ SC contractors seeking exemption of 50% EMD or price preference are required to produce an affidavit to this effect. The ST/SC contractors having Degree/Diploma in Engineering are not allowed to avail both the benefits. Both Engineering and ST/SC contractors should submit the affidavit in writing regarding the facility to the concerned officer inviting tender, otherwise they will not be entitled to get the facility.
10. If L1 bidder does not turn up for agreement after finalisation of tender, then he shall be debarred from participating in bidding for two years and action will be taken to blacklist the contractor. In that case the L2 bidder if fulfils all other criteria would be called for drawing agreement for execution of work subject to the condition that L2 bidder negotiates at par with the rate quoted by the L1 bidder, otherwise tender will be cancelled.
11. Goods & Services Tax (GST) will be imposed as applicable.
12. Other details can be seen in the bidding documents, which is available on the website www.tendersodisha.gov.in.
13. Subsequent corrigendum if required shall appear in the website. The bidder must provide the mobile no. and e-mail ID along with the tender documents for official correspondence, if any. No paper correspondence shall be made in this regard to avoid delay in finalisation of tender. In case of a lottery, it needs to be conducted in accordance with the works department order no. 12366 dtd. 8.11.2013. THIS OFFICE WILL NOT BE HELD RESPONSIBLE FOR NON-INTIMATION OF MOBILE NO/ E-mail ID OF BIDDER along with tender documents.
14. If any bidder backs out from the bidding process or make any request for alteration or modification in terms and condition of the bid shall debar the bidder from participating in the online bidding system and his portal registration shall be blocked including recommendation to registering authority for cancellation of his registration as contractor including forfeiture of bid security deposited.
15. Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.
