

2. Monthly remuneration of re-employed officers shall be fixed as per Finance Department's Office Memorandum No.24533/F dt.29.09.2022.
3. Officers, who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for engagement.
4. Officers against whom departmental proceedings or criminal cases / Vigilance inquiry are contemplated/ pending or who have been penalized for misconduct during the period of proceeding five years will not be eligible for consideration.
5. The performance of the Officers is to be reviewed periodically and documented at least once in a quarter.


