The sealed Expression of Interest should reach to the undersigned on or before dt.10.09.2024 by 1:00 PM which will be opened on the same day at 3:00 PM in presence of the vendors or their authorized representatives in the office of the undersigned. No EOI will be received after 1:00 PM on dt.10.09.2024. The vendor should attach their up to date GST clearance certificate along with quotations. The undersigned reserves the right to cancel any or all Expression of Interest without assigning any reason thereof.
